ALL SHARE INDEX:

The market activity started on a downward path, as the NGX All – Share Index shed 24 basis point to end at 141,498.22 points, causing Market Capitalization to fall by N220 billion and investor wealth to shrink.

This downturn dragged Market Capitalization to N89.524 trillion, a reduction from its prior level of N89.744 trillion.
