Investors took profits, driving a modest retreat of 213.50 points in the index to 140,716.10, down 0.15%, with Market Capitalization shedding N135 billion.

The contraction trimmed Market Capitalization to N89.063 trillion, a decline from the earlier N89.198 trillion.
