The local bourse commenced the week's trading session on a strong note, with the NGX ASI gaining 729.18 points (0.50%) to close at 147,717.22. This upward movement translated into a N465 billion rise in Market Capitalization, underscoring renewed investor confidence.

The Market's total value advanced to N93.760 trillion, reflecting a gain from N93.295 trillion recorded previously.
