After a strong week of advances, the NGX recorded a modest pullback as the index shed 64.40 points to settle at 147,742.22, reflecting a 4 basis point dip driven by profit - taking.

The market's downturn trimmed Market Capitalization to N93.776 trillion, compared to N93.817 trillion previously, implying a N41 billion decline in investors' worth.
