The Nigerian Exchange began the week on a positive trajectory, as the NGX ASI gained 963.17 points (0.64%) to settle at 149,940.81. Market capitalization also grew by N611 billion, reflecting a rise in investors' overall equity value.

At market close, capitalization settled at N95.171 trillion, marking an increase from N94.560 trillion.
