The local bourse gained 150 basis points, hitting a new high as bullish sentiment and positive momentum persisted.

The NGX extended its bullish run as the All - Share - Index (ASI) gained 2,279.34 points to 153,736.25, pushing market capitalization up by N1,446 trillion to N97.580 trillion.
