EQUITIES MARKET

ALL SHARE INDEX:

The All - Share Index climbed 49 basis points, signalling widespread gains across equities. The concurrent growth in market capitalization underscores resilient investor confidence and deepening market participation.

The local stock market continued its advance, adding 753.65 points to the All - Share Index (ASI), which closed at 154,489.90. Correspondingly, market capitalization grew by N479 billion to N98.059 trillion, reflecting improved investor confidence.
