### **EQUITIES MARKET**

#### **ALL SHARE INDEX:**

The session witnessed moderate sell-side activity, which pressured the benchmark index 1,092.22 points lower to 154,260.98, a 0.70% contraction. This downturn also reduced Market Capitalization by N693 billion.

The benchmark index decline drove a 0.70% drop in Market Capitalization, which closed at N97.914 trillion compared to N98.607 trillion, signaling reduced market valuation.
