## **EQUITIES MARKET**

#### **ALL SHARE INDEX:**

The local bourse began the week under pressure, posting a 25 basis point drop in the All – Share Index to 153,739.11 points. Consequently, market capitalization contracted by N246 billion, indicating waning investor sentiment.

Following the day's negative close, market capitalization dipped to N97.582 trillion, slightly below the N97.828 trillion recorded in the prior session.
