## EQUITIES MARKET

### ALL SHARE INDEX:

The Nigerian Equities Market witnessed a decrease in trading activity today as deals, volume and equity capitalization declined, indicating subdued investor participation and a lack of significant market movement.

The NGXASI lost to peg the All - Share - Index at 98,125.73bps as against its previous close of 98,156.71bps. This outing displayed a decrease of **-0.03%**

Market Capitalization followed suit the direction of the ASI to stand at N55.507tn, representing a **-0.03** decrease from the N55.525tn it stood at the end of the previous trading.

### MARKET ACTIVITY

Market activity as measured by the value of trades increased in the session, with daily traded volume standing at 140,771,892units, representing **-65.64%** decrease from a volume of 409,766,223units traded in the previous session.

Value of those traded stocks increased by **5.53%** in the session to stand at N9,418,632,878.40 as against a value of N8,925,056,317.10 recorded in the previous trading session.
