ALL SHARE INDEX:

The Nigerian Equities Market witnessed an increase in trading activity today as deals, volume, value and equity contribution increased, indicating positive outing to the trading session.

The NGXASI gained to peg the All - Share - Index at 99,300.38bps as against its previous close of 99,276.03bps. This outing displayed an increase of **0.02%**

Market Capitalization followed suit the direction of the ASI to stand at N56.172tn, representing a **0.02%** increase from the N56.158tn it stood at the end of the previous trading.

Market activity as measured by the value of trades increased in the session, with daily traded volume standing at 433,997,592units, representing **40.13%** increase from a volume of 309,714,210units traded in the previous session.

Value of those traded stocks increased by **57.74%** in the session to stand at N8,575,279,947.31 as against a value of N5,436,181,966.37 recorded in the previous trading session.
